

With reference to the above, the contractor M/s. Potts Devices & Systems, CORD'S Tower Building, Vallakalil Jn., Muvattupuzha. are here by informed that your tender for the above work has been accepted at estimate rate of Rs.43,282/- (Rupees Forty Three Thousand two hundred and eighty two only) which is mentioned in the accepted schedule herewith enclosed. You are requested to attend this office on or before **15 days** from the date of work order with stamp paper worth Rs.200/- (Rupees Two Hundred only) and security deposit drawn in favour of the Assistant Executive Engineer, P.H Sub Division, Nattika- 680 566. Security mentioned below and executes an Agreement and start the work within 7 days after getting necessary instructions from the Sub Division Officer.

- 1) Before executing the agreement in stamp paper, you should deposit in the Treasury bank/ Nationalised bank/Sheduled Bank / Post office of revenue deposit in favour of Assistant Executive Engineer, P H Sub Division, Nattika a security of Rs.1300/- (Rupees One thousand & three hundred only) for fulfillment of this contract.
- 2) Any failure in this direction may result in forfeiture of your earnest money and cancellation of the contract the contractor shall be liable to pay the Kerala Water Authority the entire loss that may be caused to Kerala Water Authority by the re tenders or rearrangement of the work or other wise consequent on the contractors failure to Execute the agreement of the work as provided for in clause of the notice inviting tender and all such losses will be recovered from you under the provisions of the Revenue Recovery Act or otherwise.
- 3) It must be understood that on no account will the rate once fixed be increased. Some deductions in the rates may be applicable, subject to approval from the Executive Engineer, P. H Division, Irinjalakuda.
- 4) The work should be completed within **15 days** from the date of this order.
- 5) All the terms and conditions of the notice inviting tender/ quotation shall be binding on the contractor.
