- 1 With reference to the above contractor Sri. M.M John, Mathichiparambil house, Fathimapuram P.O, Changanasserry is hereby informed that the e-tender for the above work has been accepted 2.00% below + GST mentioned in the accompanying schedule against the respective items of work. You are directed to attend this office within one week on receipt of this order OR before 19/12/2022 whichever is earlier with the required stamp paper and receipt Chelan for the security mentioned below and execute any agreement and start work within a week after getting necessary instructions from the Asst: Executive Engineer, P.H Sub Division, Changanasserry.
- 2 Before executing the agreement on stamp paper worth of Rs. 200/- the contractor should deposit a Performance guarantee of Rs: 2,100/- (At least Fifty percent (50%) of the this deposit shall be collected in the form of Treasury Fixed Deposit and rest in the form of Guarantee issued from Nationalized/ Scheduled Bank/Kerala Financial Corporation or any other forms prescribed in the revised PWD Manual) duly pledged to the undersigned for the fulfilment of the contract for which the necessary declaration form or Chelan can be had from this office. Performance Guarante will be released with required request, within one month after the DLP + 28 days and Additional Performance Guarantee within one month after submission of Final Bill to this office. Otherwise both will be forfeited without intimation.
- 3 Any failure in this direction will be liable to result to forfeiture of his special and permanent earnest money and the cancellation of the proposed contract and the contractor shall be liable to pay the Authority the entire loss that may be caused to Authority by the retender or re-arrangement of the work or otherwise consequent to the contractor's failure to execute the agreement or execute the works as provided for the clause 13 Notice inviting tender and all such loss shall be recovered from him under the provisions of the revenue recovery Act for otherwise (Vide G.O(P) 245/76/PW/dtd.19.11.1976).
- 4 It must be understood that the rates once fixed could not be increased.
- 5 The work shall be completed within Two months from the date of Agreement Or before 18/02/2023 whichever is earlier.
- 6 All the terms and conditions of the Notice inviting Tenders and tender shall be binding on the contractor (Vide G.O. (P) 245/76/PW dtd.19.11.1976.
