Before executing the agreement on stamp paper you should furnish a security deposit of **Rs.6000 (Rupees Six Thousand only)** in favour of the undersigned in which **minimum 50% should be in the form of Treasury F.D. and the rest in the form of Bank Gurantee/T.S.A/N.S.C/Post Office Term Deposit** for the due fulfillment of the contract.
2. Any failure in this direction will be liable to result to forfeiture of his special and permanent earnest money and the cancellation of the proposed contract and the contractor shall be liable to pay the Authority the entire loss that may be caused to authority by the re-tender or re-arrangement of the work or otherwise consequent on the contractors failure to execute the agreement or execute the work as provided for in Clause 13 of the Notice inviting Tenders and all such loss shall be recovered from him under the provisions of the Revenue Recovery Act or otherwise.
3. It must be understood that on no account will the rates once fixed be increased.
4. The work should be completed within **Three months** from the date of selection notice.
5. All the terms and conditions of the Notice inviting Tender shall be binding on the contractor.
