Sub:- Deposit Work – Dismantling 25mm dia GI pipe 100m and laying 65mm GI pipe and extension at Vettukkad Gramin Road near Milma, ward-16 at Choondal Panchayath - issue of work order-reg

Ref:- 1. E-tender No.40-ET/AEE/GVR/2022-23
2. Order No. A3-1927/2022 dtd. 04-05-2022 from Executive Engineer, PH Division Thrissur.

With reference to the above, you are hereby informed that your tender for the above work is accepted at the rates quoted by you ie. at 5.0% above the estimate rate is **Rs. 2,11,582/-** (Rupees Two lakhs Eleven Thousand Five Hundred and Eighty Two only) excluding GST. You are directed to attend this office on or before **28.05.2022** with the required stamp paper (0.1% of Accepted PAC) for executing the agreement and start the above work within a week after getting necessary instructions from the **Asst. Exe. Engineer, PH Sub Division, Guruvayur.**

- a) Before executing the agreement on stamp paper you should deposit an amount of **Rs. 6,400/-** (Rupees Six Thousand and Four only), of which 50% ie **Rs. 3,200/-** (Rupees Three Thousand and Two Hundred only) should be deposited in the form of Treasury fixed deposit and rest in the form of bank guarantee or any other forms and any other forms prescribed in the revised PWD manual duly pledged in favour of **Asst. Executive Engineer, P H Sub Division, Kerala Water Authority, Guruvayur** as security deposit for the fulfillment of the contract.
- b) The time allowed for executing agreement without fine will be 15 days from the date of registration of the communication (Selection Notice) in the Post Office.
- c) Further time of 10 days shall be allowed to execute agreement by realizing a fine of 1 % of the P.A.C. subject to a minimum of Rs.1000/- and a maximum of Rs. 25,000/
- d) Tender will be rejected if agreement is not executed within 15 days, and work will be awarded to the next lowest tenderer as stipulated under clause 4-10-5 of the code.


- I. The contractor will take over charge of the site within 3 days after executing agreement, and commence the work.
- II. Any failure in this direction will result in forfeiture of your special and permanent E.M.D. and cancellation of the proposed contract and the contractor shall be liable to pay the Authority the entire loss that may be caused to Authority by re-tender or re-arrangement of works otherwise consequent on the contractor's failure to execute the agreement or execute the work as provided forth the Clause 13 of the notice inviting tenders and all such loss shall be recovered from him under the provisions of the Revenue Recovery Act or otherwise.
- III. It must be understood that on no account will rates once fixed be increased.
- IV. The work should be completed within **1 month** showing proportionate progress from the date of this order. During actual execution if extension of time is found unavoidable the application is to be prepared well in advance explaining the ground with a programme for completion (in duplicate – one directly to Executive Engineer and the other through proper Channel with remarks of officers)
- V. All the terms and conditions of the notice inviting tenders and tender shall be binding on this contract also.
- VI. KWA deserves the right to recover any amount due to KWA from any other work undertaken by the contractor in KWA.
