The work is awarded to you at your quoted rate for an amount of Rs. 3,98,975/- (Rupees Three Lakhs Ninty Eight Thousand Nine Hundred Seventy Five Only) which is at the tendered PAC of Rs. 398975.25/-. **You are requested to execute the agreement within 15 days. A grace period of 10 days will be allowed beyond the allowed date within a fine of 1% of the PAC subject to a minimum of Rs. 1000/- and maximum of Rs. 25000/-** for executing the agreement and after that your offer will be rejected and the work will be awarded to the next lowest tenderer and auction will be taken as per rules and EMD will be forfeited. The work shall be started within a week after getting necessary instructions from the **Assistant Executive Engineer, Water Supply Sub Division, Varkala.**

1. Before executing the agreement on Stamp paper, the Contractor should deposit an amount of **Rs.12,000/- [Rupees Twelve Thousand Only]** towards Performance guarantee . At least 50% of performance guarantee shall be in the form of Treasury Fixed Deposit and the rest in the form of Bank guarantee any one of the Government Treasury as Savings Bank Account and the pass book pledged in favour of the under



signed and produce the pass book with stamp paper worth **Rs. 400 /-** and three sets of agreement document etc. for executing the agreement

2. It must be under stood that in no account will rates once fixed be increased.
3. The work should be completed within **Six months** from the date of this order.
4. All the terms and conditions of the Notice inviting tenders and tender shall be binding on the contractor vide G.O. (P) 245/76/PW dated: 19/11/1976.
5. GST rules will be applicable as per circular No. 0023/2018/DY. AM/FIN/KWA Dt.29/09/2018 of FM & CAO for statutory deductions
6. The Statutory deduction such GST/IT and KCWWF etc. will be effected from the Bill.
