- Any failure in this direction will be liable to result in the forfeiture of the earnest money and the cancellation of the proposed contract and the contractor shall be liable to pay the Government the entire loss that may be caused to the Government by the retender or re-arrangement of the work or otherwise consequent on the contractor's failure to execute the agreement or execute the work, as provided for in the clause 13 of the notice inviting tenders and all such loss shall be recovered from him under the provisions of "Revenue Recovery Act" or otherwise vide the G.O.(P) 245/76/PW dated 19/11/1976.
- 3 It must be understood that on no account will the rates once fixed be increased.
- 4 The work should be completed within 4 months from the date of this order.


