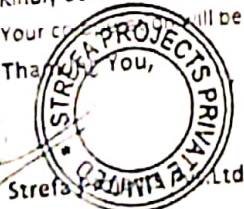
With reference to above subject, we would like to bring it to your notice that the scope of work as per the above agreement could not be completed within the specified period because of the following reason.

- a) PWD, KIIFB, NH Road permissions are not yet approved. From our side we are meeting and coordinating with concerned road departments and MLA office for getting permissions. All our pending laying works are in these roads only.

Because of the reason stated above we were unable to complete the Job in the specified period of time. Hence we are requesting you to enhance the period of completion by another Six months(16-06-2023 to 16-12-2023)

Also please take into your consideration that we did all electro fusion welding at site as per the instruction from department that additional item will be included in the RE and other than that Laying of 63mm, PN 8 HDPE pipe is not included in BOQ. But we completed the total scope as per department requisition.
