With reference to the above, you are informed that your tender for the above work has been accepted at your negotiated quoted amount of of ₹ 4,82,26,165/- (Rupees Four Crore Eighty Two Lakh Twenty Six Thousand One Hundred And Sixty Five only) which is 2.07% Above tendered PAC.You are requested to attend this office on or before 02.02.2024 with stamp paper worth value Rs.48230/- (Forty Eight Thousand Two Hundred and Thirty Only) and security deposit mentioned below and execute the agreement and start the above work within a week after getting necessary instructions from the Executive Engineer, WSP Division, Kalmandapam, Palakkad.

Before executing the agreement on stamp paper you should deposit an amount of Rs.14,46,785/- (Rupees Fourteen Lakh Forty Six Thousand Seven Hundred and Eighty Five only) ie, 3% of accepted PAC as performance guarantee as per GO(P) No. 54/2019/Fin dated. 04/05/2019 and GO (P) No. 168/2019/Fin dated. 07/12/2019.

An Additional Performance Guarantee of Rs 680621/- (Rupees Six Lakh Eighty Thousand Six Hundred and Twenty One only) shall also be deposited for unbalanced price in addition to the normal Performance Guarantee.

At least 50% of this amount shall be furnished in the form of Treasury fixed deposit as per NIT duly pledged in favour of the Superintending Engineer, P.H. Circle, Kerala Water Authority, Palakkad and rest shall be in the form of guarantee issued from any Nationalized Bank or Scheduled Bank or Kerala Financial Corporation or any other forms prescribed in the PWD manual as security for the fulfillment of the contract. The contractor will be eligible for applicable GST at applicable rate over and above the awarded amount. If you are not registered with KWA shall get themselves registered with the authority for equivalent class of registration before executing the agreement

Any failure to this direction will result in further action as per NIT conditions. The work should be completed within 8 (Eight) months from the date of handing over the site.
