Note on issues of Projects uploaded in e-PMG Portal

1) Issue # KL-3180-8033 (Road cutting)

KIIFB-Augmentation of WSS to Kollam Corporation- Supplying & Laying 1219mm dia MS Raw water pumping main from Njankadavu Intake well to Vasoorichira WTP

AS No. GO(Rt) No.14/2017/WRD dated 11/01/2017 (Amount 23500Lakh)

TS No. KWA/CE(SR)/18/2016-17 dtd 23/01/2017 (Amount Rs.14552 Lakhs)

It is project taken up with KIIFB funding to provide drinking water supply for a population of 429294 in Kollam Corporation and Kottamkara panchayath.

A portion of 1219mm MS Raw water Pumping main of the scheme is aligned through Kollam- Theni NH from Nanthirikkal to Elampalloor. An application was submitted to PWD NH wing, Kollam as on 23.11.2020 for permission to cut the Elampalloor - Nanthirikkal stretch of NH for a length of 1.052 km to lay the pipe line. This application was forwarded by PWD NH wing to MoRTH for approval. All the documents as demanded by PWD and MoRTH were submitted. Even though, NOC from other utility providers like BSNL, KSEB etc were submitted, laying permission is still pending. The entire scheme can be commissioned only if cutting permission for this stretch is obtained and 1052m of balance laying completed. Out of the total 28.13 km of RW laying, all other remaining portion, except this stretch of 1052m in the NH has been already completed.
