Before executing the agreement on stamp paper, you should deposit an amount of **Rs.1,04,92,000/-**(Rupees One Crore Four Lakhs and Ninety Two Thousand only)of which 50% ie, **Rs. 52,46,000/-** (Rupees Fifty Two Lakhs Forty Six Thousand Only) should be deposited in the form of **Treasury Fixed Deposit** and rest in the form of Bank Guarantee or any other forms prescribed in the revised PWD manualand the above documents shall beduly pledged in favour

of the Superintending Engineer, P.H.Circle, Kerala Water Authority, Thrissuras security deposit for the fulfillment of the contract.

Any failure of this direction will result in forfeiture of your earnest money and cancellation of the contract. The contractor shall be liable to pay the entire loss that may be caused to KWA on rearrangement of the work or otherwise consequent on the contractor's failure to execute the agreement or execute the work as provided for in clause no.7.22 of NoticeInviting Tenders and all such losses shall be recovered from you under provisions of Revenue Recovery Act or otherwise.
