With reference to the above you are here by informed that the tender for the above work has been accepted for an amount of **Rs.24,44,93,748 /-.(Rupees Twenty Four Crore Forty Four Lakhs Ninety Three Thousand Seven Hundred and Forty Eight only)** which is mentioned in the accompanying schedule against the respective items of work which is **9.99%** above tendered PAC. You are directed to attend this office on or before **15.12.2022** with the required stamp paper and receipted Chelan for the performance security as mentioned below and execute an agreement and start the work within a week after getting necessary instruction from the **Executive Engineer, P.H Division, Muvattupuzha** Before executing the agreement on stamp paper worth **Rs.100000/-(Rupees One Lakhs only)**, the contractor should deposit performance guarantee of **Rs 7334900/- (Rupees Seventy Three Lakh Thirty Four Thousand Nine Hundred only)** for the fulfillment of the contract for a period not less than **34 months** from the date of work order. At least 50% of this deposit shall be collected in the form of treasury fixed deposit and the rest in the form of bank guarantee or NSC.



1. Any failure in this direction will be liable to result to forfeiture of your special and permanent EMD and cancellation of the proposed contract and the contractor shall be liable to pay the authority the entire loss that may be caused to authority by the re-tender or re-arrangement of the work otherwise consequent on the contractor's failure to execute the agreement or execute the work as provided for in the Notice Inviting Tenders and all such loss shall be recovered from him under the provisions of the Revenue Recovery Act or otherwise.
2. It must be understood that on no account the rates once fixed will be changed
3. The work should be completed within **9 months from the date of this order.**
4. All the terms and conditions of the Notice Inviting Tenders and tender shall be binding on this contract also.
5. No extra items and excess quantity are to be carried out without prior written sanction from this office.
6. Instructions given in Technical circular Vol. 1, 2, 3 should be strictly followed.
7. Adequate precautions shall be taken to avoid accidents and no portion of trench shall be left unfilled without proper barricading.
8. A Format/proforma with required details of the beneficiary consumers shall be attached with the agreement of the work for filling up by the contractor and to submit the duly filled up proforma along with the bill or when wanted by departmental officers.
9. The total expenditure for the work shall be within AS amount
10. KWA licensed plumbers at Regional/Circle level included in the empanelled list issued by the MD, KWA vide letter No. KWA/ JB/P6/JJM- Legal/2020 dt. 26.4.2022 as per judgement of Hon'ble High Court of Kerala in WP(C) No. 18399 dt. 11/2/22, and appended to the NIT shall form part of the agreement and shall be engaged for providing FHTC's. MoU entered into with any plumber for giving FHTC's for this work shall be invalid.
11. You are directed to revise the schedule as per sanctioned amount and submit the revised BoQ urgently.


