Administrative Sanction for the project “KIIFB Project: TRAN 10: WRD025-06 - WSS to Ayyappankovil Panchayat ” was accorded vide reference 1st cited for Rs. 46.424 Crores and Technical Sanction was issued for the work “KIIFB Project: TRAN 10: WRD025-06 - WSS to Ayyappankovil Panchayat - PART-II , Package III- Design and construction of check dam across Periyar river at Thonithady ” vide read 2nd cited by Chief Engineer (CR) for Rs. 3.42 Crores.

Competitive e-tenders were invited for the subject work by Superintending Engineer vide read 3rd cited. Vide read 6 cited, Superintending Engineer has reported that wide publicity was arranged for the tender by publishing the Tender notice in website and in Dailies, Business Standard (All India Edition) and Malayala Manorama (All Kerala Edition).

In response to tender call two offers were received as following.

The Superintending Engineer recommended to sanction the tender submitted by Sri. Muhammed Safvan M K. as the quoted amount is reasonable and there is no chance for getting a better offer. The present work is for the urgent commissioning of CARWSS to Kattappan-Ayyappankovil.



There are 3 Packages for the scheme KIIFB- WSS to Ayyappankovil Panchayath Part II. This tender is for Package III- Design and construction of check dam across Periyar river at Thonithady. The work was awarded previously vide read 5 by limiting the quoted amount 10% above TPAC, but the contractor was not willing to do the work. Hence the Superintending Engineer cancelled the tender and retendered the work. The e Tender for Packages I & II are floated with due date 08.02.2022 and is under processing. This work is essential for assuring the source adequacy of the KIIFB scheme. Also the work of providing water connection from this scheme under JJM is in progress.

The bidder Sri. Muhammed Safvan M K is the lowest, quoted at 7.29% above TPAC, for Rs. 3,25,31,442.74/- The LMR PAC corresponding to TPAC is Rs. 3,52,50,844/-

Special Technical Committee convened vide read 7 above evaluated the tender in detail. The Tender Committee observed the following:

LMR PAC corresponding to TPAC. Rs. 3,52,50,844/-

Quoted PAC of L1 tenderer :Rs. 3,25,31,442/- (7.29% above TPAC and below LMR PAC)

10% above TPAC :Rs. 3,33,53,143/-

As per prevailing rule, the tender sanction is to be given to lowest among the three. The Special Technical Committee observed that the lowest among three is quoted PAC of L1 tenderer. Hence the Committee decided to sanction the tender in favour of Sri. Muhammed Safvan M K, Kottumala , O M Muri, Malappuram at his quoted rate of 7.29% above TPAC for the amount of Rs 3,25,31.442.74

In the above circumstances, sanction is hereby accorded to award the work “KIIFB Project: TRAN 10: WRD025-06 - WSS to Ayyappankovil Panchayat - PART-II , Package III- Design and construction of check dam across Periyar river at Thonithady ” in favour of Sri. Muhammed Safvan M K, Kottumala , O M Muri, Malappuram- 676519 at his quoted rate 7.29% above TPAC for the amount Rs. 3,25,31,443/- (Rupees three crores twenty five lakhs thrity one thousand four hundred and forty three only). The Superintending Engineer shall verify all submittals with original documents. The firm period of the tender will expire on 14/06/2022. Tender documents in original are returned herewith for further necessary action as per rules.
