24. Special Comments Recommendation, Suggestion:

The tender for this work which includes 2 Packages are tendered 9 times before individually and jointly with no fruitful result.

SE has reported that even after incurring an amount of Rs.2529.59 Lakhs under ARP/NRDWP. the water supply scheme "CARWSS to Kattappana & Ayyappancovil Villages" could not be commissioned. Also 9357 FHTC's sanctioned in JJM for Rs.5201 Lakhs in Kanchiyar and Ayyappancovil Panchayaths targeted for completion in 2022-23, can be commissioned only after commissioning of this work. SE has requested that considering the urgent necessity of commissioning the scheme "CARWSS to Kattappana & Ayyappancovil Villages" the tender may be sanctioned at the earliest.

There is only one bidder who participated in the re tender for the work. Though mode of ranking is QCBS, can not apply it because of single tender.

Lowest among 19. 20, 21 is LMR estimate cost.

25. Committee decision:

The Special Technical Committee convened verified the tender in detail. The Committee observed that as per the prevailing rule, the tender is to be sanctioned to lowest among Quoted amount, LMR PAC corresponding to TPAC and 10% above TPAC. The Single bidder M/s. Chicago Constructions International(P) Ltd has quoted 53.25% above TPAC. The LMR justification amount is only 3.03% above TPAC. The TS for the work is issued as two packages and the work is tendered several times separately and jointly but was not effective. Since quoted rate is very high, Committee decided to



cancel the tender and direct SE to verify and prepare realistic estimate based on site condition urgently. The packages shall be revised if necessary in such a way to include electro mechanical and inter connection works for urgent commission of the ARP / NRDWP Scheme.
