You are requested to attend this office on or before 25.04.2022 with stamp paper worth Rs.1,00,000/- (Rupees one lakh only) and security deposit mentioned below and execute the agreement and start the above work within a week after getting necessary instructions from the Executive Engineer, WSP Division, Palakkad.

Before executing the agreement on stamp paper you should deposit an amount of Rs. 80,25,000/- (Rupees eighty lakh and twenty five thousand only) ie,3% of agreed PAC as performance guarantee. At least 50% of this

amount shall be furnished in the form of Treasury fixed deposit duly pledged in favour of the Superintending Engineer, PH.Circle, Kerala Water Authority, Palakkad and rest shall be in the form of guarantee issued from any Nationalized Bank or Scheduled Bank or Kerala Financial Corporation or any other forms prescribed in the PWD manual as security for the fulfillment of the contract.

Any failure to this direction will result in further action as per NIT conditions. The work should be completed within 9 (nine) months from the date of award of the work.
