With reference to the above, you are informed that your tender for the above work has been accepted at your quoted amount of Rs. 7,11,37,484/- (Rupees Seven crore Eleven lakh Thirty seven thousand Four hundred and Eighty four only) which is 13.41 % below the tendered PAC of Rs. 8,21,51,725/- (excluding GST). You are requested to attend this office on or before 18.04.2023 with stamp paper worth Rs. 71140/- (Rupees Seventy one thousand one hundred and fourty only) and security deposit mentioned below and execute the agreement and start the above work within a week after getting necessary instructions from the Executive Engineer, Project Division, Chittur.

Before executing the agreement on stamp paper you should deposit an amount of Rs. 21,34,125/- (Rupees Twenty One lakh Thirty four thousand One hundred and Twenty five only) ie, 3% of agreed PAC as performance guarantee and Rs. 40,13,702 /- (Rupees Forty lakh Thirteen thousand Seven hundred and Two only) as Additional Performance guarantee as per GO (P) No

54/2019/Fin dated 04/05/2019 and GO (P) No 168/2019/Fin dated 07/12/2019. At least 50% of this amount shall be furnished in the form of Treasury fixed deposit as per NIT duly pledged in favour of the Superintending Engineer, P.H.Circle, Kerala Water Authority, Palakkad and rest shall be in the form of guarantee issued from any Nationalized Bank or Scheduled Bank or Kerala Financial Corporation or any other forms prescribed in the PWD manual as security for the fulfillment of the contract. The contractor will be eligible for applicable GST at applicable rate over and above the awarded amount.

In compliance with the judgment dated 11.02.2022 of the Hon'ble High Court of Kerala in WP(c) Nos 18234 & 18399 of 2020, the connection shall only be provided through the licensed Plumbers and the number of connections have to be distributed in such a way that each Plumber can get an equitable number of connections.

Any failure to this direction will result in further action as per NIT conditions. The work should be completed within 6 (Six) months from the date of award of the work.
