

ORDER

The work was awarded to Sri. Muhammad Ali, Thadathil House, Kanayam Post, Shornur - 679121, vide work order cited 1st above and the contractor has executed the agreement vide reference 2nd cited. As per work order condition, the work should be completed on or before 31.03.2021.

But the contractor could not complete the work within the agreed time and based on the recommendation of the Executive Engineer, P.H.Division, Irinjalakuda time extension was granted upto 31.03.2022 vide 1st supplemental agreement 3rd cited, extended upto 30.06.2022 vide 2nd supplemental agreement 4th cited and again extended upto 31.12.2022 vide 3rd supplemental agreement 5th cited .

The contractor Sri. Muhammad Ali has requested time extension upto 31.05.2024 as per letter read 6th above. The Executive Engineer, P.H. Division, Irinjalakkuda reported that the work was delayed due to a rise in ground water level due to rain and delay in getting road cutting sanction from NH and PWD authorities. The Executive Engineer has also recommended to grant time extension upto 31.03.2024 without imposing any fine as per letter read 7th above.



In the above circumstances, time of completion of the work "JJM Thrissur District Vadanappilly Grama Panchayath — Providing FHTC to Rural households

and allied works – Retrofitting and Augmentation of Existing Rural Water Supply Scheme" is extended upto 31.03.2024 without imposing fine.

Contractor is directed to execute the supplementary agreement within 7 days of receipt this order. Failing which may treated as the lapse of the contractor and this order will automatically get cancelled. New order will be issued to pre-close the work without further notice.
