ORDER

Administrative Sanction for the subject work was accorded vide read1st cited forRs 46.424 Crore and Technical Sanction was issued vide read 2nd cited by the Chief Engineer(CR) for Rs. 2064.20 lakhs (Rs.1431Lakh +633.20 Lakh)

Competitive e-Tenders were invited by the Superintending Engineer, P.H circle, Muvattupuzha, vide read 3 cited, with the due date 19.08.2022. Wide publicity was arranged for the tender through newspapers and publishing in website. Vide read 4 above, Superintending Engineer has submitted the tender documents and reported that the tender notice was published in etenders.kerala.gov.in ,Kerala Koumudi , Mathrubhumi, (All Kerala Editions), Business Standard (All India Edition) Dailies. The firm period of the tender is 120 days from the last date for submission of tender ie. 16.12.2022. The tendered PAC of the work is 168276029 /-.The scope of work of this tender include construction of pump house and sump, laying gravity main and pumping main, Electro-mechanical Works and Road Restoration for BM & BC road surface,



Restoration of concrete shoulder.

In response to the tender call, 2 offers were received

Two bidders quoted for this work. The bidders Sri.Joseph John, Monipillil house, Avoli P.O, Anicadu, Muvattupuzha, Ernakulam satisfy technical and financial criteria stipulated in the NIT and M/s Electric Project Consultants, MP II/503,Makkaraparamba. Malappuram-676507 JV with Sri. M.Ashraf, Moolamkuzhiyil House, Pazhamalloor P.O. Kottilangadi(Via) Malappuram satisfies technical but does not satisfy the financial criteria.

The disqualified bidder M/s Electric Project Consultants, MP II/503,Makkaraparamba. Malappuram-676507, was submitted a complaint to Superintending Engineer Muvattupuzha on 05.09.2022 to reconsider their tender. Vide Proceedings No. SE/PHC/MVPA/D4/T21/2022-23 dated 03.09.2022 of Superintending Engineer PH Circle, Muvattupuzha informed that M/s Electric Project Consultants, MP II/503,Makkaraparamba. Malappuram-676507 satisfy technical criteria does not satisfy financial criteria and hence tender committee consider this as single tender. Any objection / complaint regarding this pre qualification shall be reported through e-mail with in three days from the date of order. Superintending Engineer PH Circle, Muvattupuzha reported that no reply was received. Hence final pre qualification proceedings issued by Superintending Engineer Muvattupuzha on 17.09.2022. Fixing the opening of price bid on 19.09.2022. Hence this tender becomes a single tender. As this is a re tender and Sri. Joseph John pre qualify for this tender.

The Tender Committee convened vide read 5th evaluated the tender in detail.



- a). LMR PAC corresponding to tendered PAC - Rs 16,93,28,115 (0.63% above)
- b). Quoted PAC - Rs. 23, 22, 27,614.40 (38% above TPAC)
- c). 10% above TPAC - Rs 18, 51, 03,631.90/-

As per prevailing rule vide read 6th cited, the tender can be sanctioned to lowest among Para-a, b, c above. Among this para (a) LMR PAC corresponding to tendered PAC - Rs 16,93,28,115 (0.63% above) is found the lowest.. The Tender Committee evaluated the tender received for the work in detail. The bidder Sri. Joseph John, Monipillil house, Avoli P.O, Anicadu, Muvattupuzha, Ernakulam satisfy technical and financial criteria stipulated in the NIT. The committee decided to award the work at LMR PAC corresponding to tendered PAC - Rs 16,93,28,115 .(Rupees Sixteen crore Ninety Three Lakh Twenty Eight Thousand One Hundred and Fifteen only) with direction to Superintending Engineer to verify all the submittals with original documents before executing agreement and Collect MoU with the licenced contractor in PWD for road work.

The validity of tender is upto 16.12.2022.

Under the above circumstances, considering the recommendations Superintending Engineer, PH Circle, Muvattupuzha and that of Tender Committee, tender for the work KIIFB- Project Tran 10: WRD 025-06 WSS to Ayyappankovil Panchayath –Part II- Package 1&II is hereby sanctioned in favour of Sri. Sri. Joseph John, Monipillil house, Avoli P.O, Anicadu, Muvattupuzha, Ernakulam, at). LMR PAC corresponding to tendered PAC (0.63% above) for an amount of Rs. 16,93,28,115 /-. (Rupees Sixteen crore Ninety Three Lakh Twenty Eight Thousand One Hundred and Fifteen only). The Superintending Engineer shall ensure that all recommendations of Tender Committee stated above is strictly complied.
