The subject work was awarded to the Contractor Sri Sunny K George, Koottanal House, Munnad P.O., Kasargod. and has executed the agreement vide read 1<sup>st</sup> cited. As per the agreement condition, the work was to be completed on or before 16/02/2023. But the contractor could not complete the work within the agreed time and vide read 2<sup>nd</sup> cited has requested for extension of time of completion of the work up to 15/04/2023. He has stated that the work has been delayed due to delay of getting road cutting sanction from PWD.

The Assistant Executive Engineer reported vide read 3<sup>rd</sup> cited that the work could not be completed in time because there is a delay due to delay of getting road cutting sanction from PWD. Reson for delay the work is genuine. The Assistant Engineer has recommended for time extension stating that the work could not be completed in time since there is a delay due to delay of getting road cutting sanction from PWD. The Assistant Executive Engineer has recommended extending the time of completion of the work up to 15/04/2023 without imposing fine.
