With reference to the above, you are hereby informed that your tender for the above work is accepted at the amount of **Rs. 3,34,07,189/-**(Excluding GST) which is 3.75% above the TPAC of Rs. 3,21,99,701/-.

You are directed to attend this office within **15 days** from the date of this work order with required **Kerala Govt. stamp paper worth Rs. 33,500/-** to execute the agreement and start the work after getting necessary instructions from the Executive Engineer, Project Division Malappuram.

1. Before executing the agreement, you should deposit a **Performance guarantee of Rs. 16,70,400/-**(Rupees Sixteen lakhs Seventy thousand and Four hundred only) which is 5% of the

- accepted PAC. In which at least 50% shall be given in the form of Treasury Fixed Deposit and the balance amount in the form of Bank Guarantee or any other forms prescribed in the revised PWD manual and produce the pass book duly pledged in favour of Superintending Engineer, P.H. Circle, K.W.A, Malappuram for fulfillment of contract. The EMD furnished along with tender will be released on receipt of the Security Deposit and executing agreement.
2. Any failure in this direction will be liable to result in the forfeiture of your offer, Permanent Earnest Money and the cancellation of the proposed contract and the contractor shall be liable to pay the Authority the entire loss that may be caused to Authority by the re-tender or the rearrangement of the work or otherwise consequent on the contractor's failure to execute the agreement or execute the work as provided for in the clause of the Notice Inviting Tender and all such loss shall be recovered from the contractor under the provision of the Revenue Recovery Act or otherwise.
 3. It must be understood that on no account the rates once fixed will be increased. Payment made as per the availability of funds for the scheme.
 4. The work should be completed in all respects within **15 (Fifteen) months** from the date of work order.
 5. All the terms and conditions of the Notice Inviting Tender shall be binding on the Contract.
 6. The contractor shall take over charge of the site within 05 days after executing agreement and commence the work.
 7. The rates quoted are of inclusive of all Taxes but excluding GST.
 8. The Contractor should complete the work in all respect as per scope of work/accepted schedule within the **Accepted PAC Rs. 3,34,07,189/-**
 9. The Executive Engineer should ensure that payments are made after satisfactory completion of the work.
 10. The contractor will be eligible for applicable GST over and above the quoted amount as per the Govt. Circular No. 18/2019/Fin dated 01/03/2019.
