JUDGMENT

The grievance highlighted by the petitioner, regarding the refusal to relieve him without risk and cost from the work awarded as per Ext.P2, stands substantially allayed by the issuance of Ext.P10 order dated 10/10/2022. Therein, the third respondent has stated as under;

"Under the above circumstances and in light of the judgment dated, 16/09/2022 of the Hon'ble High Court in WP(C)No.18521/2022, sanction is here by accorded to terminate the contract without the risk and cost. The contractor should carry out all other works included in the original contract other than works along NII 966 satisfactory. The Executive Engineer, Project Division, Malappuram is directed to arrange the balance work as per the norms laid down by the NHAI so that the scheme can be commissioned without further delay."

2. In the light of the above developments, the writ petition is

closed directing respondents 3 and 4 to pay the amounts due under the bills submitted by the petitioner, with respect to the works already executed, as expeditiously as possible.

The writ petition is closed accordingly.
