### ORDER

As per Government order read as 1<sup>st</sup> paper above, Administrative Sanction for the KIIFB funded project WSS to Ayyappankovil Panchayat in Idukki District was accorded for an amount of Rs.47.50 crores and sanction from KIIFB was obtained for Rs 46.424 crores, vide Proceedings read as 2<sup>nd</sup> paper above.

2. As per Code 14 of Part B, KIIFB Code, "All funding approvals for infrastructure development projects accorded by KIIFB should have validity till the last installment of fund release unless otherwise stated in the funding approval order subject to the condition that the work contract should be signed between the SPV and the work contract within twelve months of issuing the funding approval order by KIIFB. If the work contract is not signed within twelve months from the date of funding approval order, such projects shall be invalidated automatically and the SPV shall obtain revalidation order from KIIFB for the continuance of such projects".



3. Vide letter read as 3<sup>rd</sup> paper above, Managing Director, Kerala Water Authority requested to revalidate Administrative Sanction for KIIFB funded WSS to Ayyappankovil Panchayat in Idukki district since the work contract is not signed within the prescribed time limit.

4. Government have examined the proposal and the revalidation request in the prescribed format was forwarded to the Project Appraisal Division of KIIFB for approval. Vide letter read as 4<sup>th</sup> paper above, KIIFB has informed that the request for revalidation from the SPV for the project is approved by KIIFB subject to the ratification of forthcoming Board Meeting of KIIFB.

5. Government are pleased to revalidate the Administrative Sanction for the KIIFB funded project WSS to Ayyappankovil Panchayat in Idukki District subject to the ratification of forthcoming Board Meeting of KIIFB.
