WHEREAS the Contractor could not complete the work within the period of time of completion in the Principal agreement, based on the request on the contractor and recommendation of the Executive Engineer, Water Supply Division, Kochi-18, the Authority agreed to extend the time of completion from 04.01.2023 to 30.03.2023 without imposing fine vide order No. PHC/CHN/JJM/11554/2021 dtd 22.03.2023.



AND WHEREAS the Authority have agreed to allow extension of time for the completion of said work subject to the terms and conditions hereinafter appearing.

- 1) The period of time for completion of the work under the principal agreement is further extended from 04.01.2023 to 30.03.2023 without imposing fine vide order No. PHC/CHN/JJM/11554/2021 dtd 22.03.2023.
- The Contractor shall carry out all further works under the Principal Agreement within the said extended period at the rate and in the manner to therein subject to all the other conditions prescribed in the said agreement and shall not claim any enhance rate for such items of works on account of time, either due to the increase in rate of labour or materials or on any other ground whatsoever.

As modified above, the principal deed shall be and remain in full force and effect.
