All materials shall be supplied by the contractor in a phased manner as per the phased supply schedule prepared by the Head Works Division, Aruvikkara. Each supply of material shall be done by the contractor after getting written instruction from the Executive Engineer concerned.

Any failure in complying with the above instruction will result in cancellation of the work and the work will be arranged at your risk and cost as per rules in force. A copy of the accepted schedule is enclosed.
