With reference to the above, you are informed that your tender for the above work has been accepted at an amount of Rs. 6,46,57,529/- (Rupees Six crore forty six lakh fifty seven thousand five hundred and twenty nine only) at current LMR vide ref (4) which is 2.125 % below the tendered PAC of Rs. 6,60,61,624/- (excluding 18% GST). You are requested to attend this office on or before 16.03.2022 with stamp paper worth Rs. 64,700/- (Rupees Sixty four thousand and seven hundred only) and security deposit mentioned below and execute the agreement and start the above work within a week after getting necessary instructions from the Executive Engineer, P.H Division, Shornur.

Before executing the agreement on stamp paper you should deposit an amount of Rs. 32,32,900/- (Rupees thirty two lakh thirty two thousand and nine hundred only) ie, 5% of agreed PAC as performance guarantee. At least 50% of this amount shall be furnished in the

Treasury fixed deposit duly pledged in favour of the Superintending Engineer, PH. Kerala Water Authority, Palakkad and rest shall be in the form of guarantee issued in any Nationalized Bank or Scheduled Bank or Kerala Financial Corporation or any other forms prescribed in the PWD manual as security for the fulfillment of the contract.

Any failure to this direction will result in further action as per NIT conditions. The work should be completed within 6 (six) months from the date of award of the work. The earlier work order issued vide ref(3) hereby stands cancelled.
