ORDER

The State Government, as per letter read as 1st paper above submitted, project proposals of 2 Water supply schemes amounting to Rs.8000.00 Lakh for consideration of NABARD assistance under RIDF XXVII.

2. NABARD, as per letter read as second paper above, has sanctioned a loan assistance of Rs.6712.15 Lakh under RIDF XXVII for 2 Water supply projects at a total financial outlay of Rs.7896.65 lakh(after reducing ineligible cost of Rs.103.35 Lakh from the requested Total Financial Outlay of Rs.8000.00 Lakh)

3. In the above circumstances, Government are pleased to accord Administrative Sanction for the 2 projects sanctioned by NABARD under RIDF XXVII, as detailed below, at a total outlay of Rs. 7896.65 Lakh (Rupees Seventy Eight Crore Ninety Six Lakh and Sixty Five Thousand only) availing a loan of Rs.6712.15 Lakh (Rupees Sixty Seven Crore Twelve Lakh and Fifteen Thousand only) from NABARD for implementing the projects under the head of account "4215-01-102-98(01)-
