1) Before executing the agreement on stamp paper, the contractor should deposit a total security of ₹ 1,02,99,000/- (Rupees One Crore Two Lakhs Ninety Nine Thousand Only) vide ref. (5), out of which at least ₹ 51,49,500/- may be deposited in the Treasury Savings Account of Government of Kerala and the rest in the form of Bank guarantee / Treasury Savings account of Government of Kerala/National savings bank / Post office term deposit duly pledged in favour of Superintending Engineer, Kerala Water Authority, PH Circle, Kochi-11 valid upto a minimum period of 2 year for the fulfillment of the contract.

Since the quoted rate is more than 10% below the estimate rate, Additional Performance Guarantee for ₹ 2,96,16,613/- (Rupees Two crore Ninety six Lakhs sixteen thousand six hundred and thirteen Only) shall be submitted by the bidder vide and 7th cited. out of which at least ₹ 1,48,08,307/- may be deposited in the Treasury Savings Account of Government of Kerala and the rest in the form of Bank guarantee / Treasury Savings account of Government of Kerala/National savings bank / Post office term deposit duly pledged in favour of Superintending Engineer, Kerala Water Authority, PH Circle, Kochi-11 valid upto a minimum period of 2 years for the fulfillment of the contract.

2) Vide reference 6th cited, stamp paper of cost ₹1,00,000/- which is (0.1% of contract value – minimum Rs.200/- and maximum up to Rs.1 lakh ) to be submitted to execute the agreement.

3) Any failure in this direction will be liable to result to forfeiture of his special and permanent earnest money and the cancellation of the proposed contract and the contractor shall be liable to pay the Authority the entire loss that may be caused to authority by the re-tender or re-arrangement of the work or otherwise consequent on the contractor's failure to execute the agreement or execute the work as provided in the Notice Inviting Tenders and all such loss shall be recovered from him under the provisions of the Revenue Recovery Act or otherwise.

4) It must be understood that in any account the rates once fixed will not be increased.

5) The work should be completed within 9 months from the date of selection notice.

6) All the materials shall be supplied by the contractor in a phased manner as per the phased supply schedule prepared by the agreement authority, based on the recommendation from the Executive Engineer as per road cutting sanction by other agencies.

7) No mobilization advance will be granted for the execution of this work.

8) While making payment for the bill to be made to the contractor for the total value of the work rate plus the applicable GST rate.

9) Work program chart shall be submitted by the contractor at the commencement of the work.

10) All the terms and conditions of the Notice Inviting Tenders and tender shall be binding on the Contractor.

16) The Abnormally High Quoted and Low Quoted Items will be regulated by the GO cited (8) and NIT Conditions. Front loading will be controlled by NIT conditions corresponding to phased supply of materials.
