Minutes of the meeting convened by Hon'ble MP, Sri.N.K Premachandran Kollam , on 21.01.2022 at District Collector's Chamber regarding pending NH -183 laying sanction for project under Project Division, Kerala Water Authority, Kollam

The meeting was convened in continuation to the meeting held on 20-01-2022 to review the pending sanctions for NH laying in regard of the ongoing project under Project Division, Kerala Water Authority, Kollam. The meeting started at 3.00PM and the District Collector welcomed all the participants.

1. Augmentation of Water Supply Scheme to Kollam Corporation

Executive Engineer KWA explained that the decision regarding the sanction for laying of the 1219mm MS raw water pumping main of the scheme from Elampalloor to Nanthirikkal, where it has to be aligned along the NH-183, is still pending. The sanction has been applied via MoRTH as on 29/06/2021, but no reply received, yet, and meanwhile the road has been resurfaced on 11/09/2021. Now, KWA has again resubmitted the request in RoW, as on 11/01/2022.

Executive Engineer, on behalf of MoRTH replied that as the road has been resurfaced, Kerala Water Authority has to move for special sanction for NH laying from MoRTH.

Decisions:-

1. Decision taken to apply for special sanction from MoRTH for laying 1219mm MS pipe from Elampalloor to Nanthirikkal.
