The contractor Sri. K.O.Jose, Kelakath house, Old Marthoma church road, Perumbavoor had executed the agreement vide reference read 1 above with a time of completion of 6 months.

The time of completion period was expired on 22.09.2020 whereas the contractor could not complete the work within the period specified in the principal agreement and he has submitted an application requesting for time extension for completing the work for a period up to 21.02.2021 as 1^{st} time extension and up to 31.08.2021 as 2^{nd} time extension and up to 30.11.2021 as 3rd time extension without imposing fine. And the contractor executed the 1^{st} , 2^{nd} & 3^{rd} supplemental agreements respectively.

The contractor again submitted an application vide reference 2nd cited requesting for further extension for a period up to 31.01.2022 by stating that the delay occurred due to continuous depression in the Arabian sea and heavy rain, the remaining tarring work was interrupted.

As per reference 3rd read, the Executive Engineer, Project Division, Chittur has recommended for granting time extension up to 31.01.2022 without imposing fine and recommending the same reasons as above. Under these circumstances, the time extension is hereby granted up to 31.01.2022 from 30.11.2021 without imposing fine.
