The above work is awarded to you at LMR Estimate amount of Rs. 17,85,554/- (Rupees Seventeen Lakh Eightyfive thousand Five Hundred and fifty four only) which is 4.29 % above the tendered PAC of Rs 17,12,032/- You are requested to deposit an amount of Rs 53,600/-(Rupees Fifty-three thousand and Six Hundred only) towards performance guarantee. At least 50% of performance guarantee should be in the form of Treasury fixed deposit and the rest of performance guarantee will be in the form of Bank guarantee from

any nationalized or scheduled bank which will remain valid till 28 days from the completion of defect liability period in favour of undersigned. Necessary countersigned Chelan and application for opening the treasury savings Bank Account will be issued from this office as per request.

After executing the agreement you are requested to contact the Assistant Executive Engineer - V, Project Division, Thiruvananthapuram and start the work as per his direction.

The work should be completed in all respects within 3 months from date of this letter.
