With reference to the above and further to our letter ref(2) and (5) above we are requesting for a time period extension for Four months considering present site conditions. We had tried our level best to complete the job in the above stipulated time and it could not be completed for the following reasons which were beyond our control.

- 1. The connections required for 4 nos pump houses are not yet received from KSEB. This is delaying the commissioning of the pump houses thereby. Until and unless the power supply is received the jobs cannot be progressed further. The above time period is based on the expectation of getting the KSEB connections within the next two weeks.
- 2. Non availability of FHTC connections:- There are around 450-560 FHTC connections are still pending and we are not receiving any connection requirements from the panchayaths. This lack of connections are also added to the delay period.

Because of the reasons stated above we are unable to complete the project in the stipulated time period. Hence we are requesting you to extend the completion period for another Four months (up to 9.07.2024) the time period which we were requested by our earlier letter above Also we are requesting you to issue the clearances for the PWD road so that we could complete the balance jobs. As stated above the reasons for the delay is not attributable to us we are requesting you to extend the time period without imposing any sort of penalty on us.
