With reference to the above you are hereby informed that the tender for the above work has been accepted for an amount of Rs. 3.25.31.443/- (Three Crore Twenty five lakh Thirty One thousand Four hundred and Fourty Three rupes only) which is mentioned in the accompanying schedule against the respective items of work which is 7.29 % above TPAC. You are directed to attend this office on or before 01.04.2022 with the required stamp paper and receipted chalan for the performance guarantee as mentioned below and execute an agreement and start the work within a week after getting necessary instruction from the Executive Engineer, Project Division, Kattappana.

1. Before executing the agreement on stamp paper worth Rs.32540/- (Rupees Thirty Two Thousand Five hundred and Fourty only), the contractor should deposit performance

Nine hundred and Fourty Five only) for the fulfillment of the contract for a period not less than 33 months from the date of work order. At least 50% of this deposit shall be collected in the form of treasury fixed deposit and the rest in the form of bank guaran or NSC.

- 2. Any failure in this direction will be liable to result to forfeiture of your special and permanent EMD and cancellation of the proposed contract and the contractor shall be liable to pay the authority the entire loss that may be caused to authority by the re-tender or re-arrangement of the work otherwise consequent on the contractor's failure to execute the agreement or execute the work as provided for in the Notice Inviting Tenders and all such loss shall be recovered from him under the provisions of the Revenue Recovery Act or otherwise.
- 3. It must be understood that on no account the rates once fixed will be changed
- 4. The work should be completed within Nine months from the date of this order.
- All the terms and conditions of the Notice Inviting Tenders and tender shall be binding on this contract also.
- No extra items and excess quantity are to be carried out without prior written sanction from this office.
- 7. Instructions given in Technical circular Vol. 1, 2, 3 should be strictly followed.
- Adequate precautions shall be taken to avoid accidents and no portion of trench shall be left unfilled without proper barricading.
- 9. All orders/instructions issued by KIIFB will be valid for this work.
