ORDER

The contractor Sri.K.Rameshan, KWAContractor, Kedharam House, KSHB Colony, Malaparamba(PO), Kozhikode, Kerala had executed the agreement vide read 1 above with a time of completion of 12 months. The time of completion period was expired on 18.09.2023 whereas the contractor could not complete the work within the period specified in the principal agreement and he has submitted an application vide reference 2nd cited, requesting for time extension for completing the work for a period up to 31.12.2023 from 18.09.2023 without imposing fine. The contractor stated that the reason for granting time extension is the permission for road cutting was not obtained from the PWD Authority because of Manson Ban the permission got on the date August 15 only, this delayed the work. The materials not arrived at the site for the construction of OHSR because of heavy rain in that area(Vakkodan Hill), As per reference 3rd read above, the

Executive Engineer, WSP Division, Palakkad has recommended for granting time extension up to 31.12.2023 without imposing fine and reported the same reasons as above. As per Schedule 70km pipe line lying to be completed out of this 45.07km is already completed. The OHSR work is also 50% completed.

Under these circumstances, the time extension is hereby granted up to 31.12.2023 from 18.09.2023 without imposing fine.
